

## **Overview of Eligible Services**

## Services eligible\* for reimbursement:

- Outpatient counseling and mental health services (including telehealth);
- Group therapy: applicable to individuals with no insurance coverage, who are related to a survivor, and for whom a survivor's therapist provides a recommendation for in writing;
- Extended family therapy (including fiancée, and domestic partners\*\*): applicable to individuals with no
  insurance coverage, who are related to a survivor, and for whom a survivor's therapist provides a
  recommendation for in writing;
- Inpatient hospitalization with a mental health diagnosis;
- Residential treatment with a mental health diagnosis;
- FDA-approved\*\*\* oral and nasal pharmacy services;
- Ketamine infusion therapy;
- Medical procedures for related physical injuries (as approved by a mental health provider or primary care physician in writing);
- Holistic treatments related to mental health that are not explicitly specified under the current Fund Guidelines, (e.g., somatic yoga therapy, acupuncture, etc.) as approved by a mental health provider or primary care physician in writing, which may be submitted for consideration of eligibility;
- Service animals and emotional support animals.

## Services potentially eligible for reimbursement:

• Partial hospitalization with a mental health diagnosis, which may be submitted for consideration.

\*Services that are not expressly listed as ineligible may be submitted for consideration and are reviewed on a case-by-case basis. If you are not certain if the service you are receiving--or are interested in receiving--is eligible, please contact JND Legal Administration.

- 1. Are in a consensual relationship of mutual support, caring and commitment;
- 2. Share the common necessities of life, including a principal residence;
- 3. Are not related by blood in a manner that would bar marriage in their state of principal residence;
- 4. Are not married or in any other domestic partnership; and
- 5. Are at least 18 years of age and otherwise competent to enter into a contract.

Domestic partners should either provide a letter attesting that they are in a domestic partnership or, if their state of principal residence recognizes domestic partnerships, provide a copy of a completed Declaration of Domestic Partnership (or equivalent form) for their state.

\*\*\*Non-FDA-approved medications or medicinal treatments (e.g., psilocybin) will be considered with written approval from a licensed mental health professional or primary care physician.

Survivors with insurance will supply a copy of Explanation of Benefits (EOB) from all insurance companies that covered outpatient services, along with a completed Reimbursement Form.

Survivors who do not have insurance will supply a paid invoice or superbill from the mental health provider or primary care physician, along with a completed reimbursement form.

Requests previously submitted to and reimbursed by the former fund administrator are not eligible for reimbursement.

<sup>\*\*</sup>Domestic partners (as part of a domestic partnership) are defined as two persons who:



Provisions of the MSU Counseling & Mental Health Services Fund:

- All services must be provided or prescribed by a licensed mental health professional;
  - Refer to the listing of eligible provider types;
    - **Exceptions:** medical procedures for related physical injuries (as approved by a mental health provider or primary care physician in writing) and visits with a primary care physician as it relates to treatment or medication maintenance for mental health;
- Reimbursement is limited to out-of-pocket expenses, including deductibles, co-pays or co-insurance;
- All available insurance coverage must be exhausted to qualify for reimbursement;
- The Fund is the payor of last resort;
- Reimbursement requests for eligible services must be submitted within 3 years from the date of service.

Services not eligible\* for reimbursement include, but are not limited to:

- Partial hospitalization that is **not** related to the treatment of mental health, or for medical procedures for related physical injuries that are **not** approved by a licensed mental health professional or primary care physician in writing;
- Hospitalization for conditions other than mental health treatment, or for medical procedures for related physical injuries that are not approved by a licensed mental health professional or primary care physician in writing;
- Non-FDA\*\*-approved prescription medications;
- Referral services, such as an Employee Assistance Program (EAP).
